State employees may be eligible for the Public Service Loan Forgiveness Program. Keep reading to see whether you might qualify.

## Virginia State Employee Loan Program (VSELP)

This will be the last year for the Virginia State Employee Loan Program (VSELP). The program will remain active with funding state loans until Friday, December 29, 2023. Eligible loans received on December 28th will be funded by COB Friday, December 29th. Loans will still be paid back through payroll deduction as agreed per the employee's loan authorization agreement, up until the loan's maturity date which should be August 18, 2024.
